- Package Malt Liquor License, including Sunday (\$75)** Permits sale of malt liquor by the package, Sunday through Saturday
- Wholesale Liquor License (\$300)** Permits wholesale sales of intoxicating liquor containing not in excess of 22% of alcohol by weight to a person, partnership, association of persons, or corporation duly licensed to sell intoxicating liquor at retail.
- Tasting License (\$37.50)** Permits a person licensed to sell intoxicating liquor in the original package at retail to conduct wine, malt beverage and distilled spirit tastings on the licensed premises.
- Picnic License (\$37.50)** Permits non-profit organizations to sell intoxicating liquor at a picnic, bazaar, fair or similar gathering for consumption on premises where sold for no more than seven consecutive days.
