The keeping of domestic fowl is subject to Full Compliance with the City Municipal Code.

SECTION 210.160: POSSESSION OF DOMESTIC FOWL

(Below are some highlights of the above referenced Code Section 210.160, the section in its entirety is available online at Hazelwoodmo.org)

1. No more than three (3) female domestic fowl may be kept on any one lot; no males or crowing female fowl are allowed.
2. No fowl or eggs sold and slaughtering on the property is permitted.
3. Domestic fowl shall be housed in a coop not larger than thirty (30) sq. ft. and provide a minimum of four (4) sq. ft. per fowl.
4. Coop/run shall be ten (10) feet from principle structure and property lines or may be attached to the garage. One coop/run per lot.
5. Coop/run area shall be professionally constructed, with materials used in commercial coops. (Building permit is required for coop/run)
6. Coop/run shall not be visible from ground level of adjoining properties or public or private streets; buffer must be 100% opaque.
7. Buffer can be vegetation at least three (3) feet in width, fencing or combination of both. (Permit required for fencing)
8. Coop/run shall be kept clean, maintained, ventilated, safe and sanitary. Also designed to prohibit access by predators.
9. Manure or waste regularly shall be collected and properly removed promptly to prevent odor and conditions conducive for disease.
10. Food for domestic fowl in a rodent-proof, insect-proof and leak-proof container and kept protected and dry.
11. No person shall keep domestic fowl in a manner as to create a nuisance or allow fowl to be outside of their coop/run.
12. The applicant and recipient of this "Domestic Fowl Registration Permit" shall assure compliance with this section and all City Ordinances.
13. Obtaining of the this "Domestic Fowl Registration Permit" authorizes City of Hazelwood to enter property to assure all City requirements and Codes are complied with.
14. "Domestic Fowl Registration Permit" can be revoked if it all City requirements and Codes are being violated.
